Our services are available throughout Scotland, both in local communities and in the courts.

We balance our consistent approach with personalised packages of support specific to the needs of people whose lives have been disrupted through crime. VSS works alongside our partners to listen to the views and experiences of victims and witnesses.


Though our core funding comes from the Scottish Government, we're independent from them and can therefore provide a critical lens to all that is happening within justice from a victims' perspective. We have a relatively small staff team of just over 100 employees who are supported by hundreds of volunteers. This team of dedicated, highly trained volunteers provide practical and emotional support to victims and witnesses across Scotland.

# **The Future - Aims/Principles**

Based on the solid foundations we have built for our organisation in previous years, 2021-2023 is the first half of our new strategy: *Empowering people affected by crime 2021-2026*.

VSS Strategy 2021-2026: Empowering people affected by crime – which will last for the duration of the next Scottish Parliament until 2026.

As Scotland recovers from the coronavirus pandemic, we have a tremendous opportunity to think innovatively about how justice and support services are delivered. Our new strategy therefore focuses on four strategic priorities for all.





#### **EMPOWER**

People affected by crime by providing high quality, outcome-focused support and care to all who need it.



#### **TRANSFORM**

Victims' and witnesses' experiences of the criminal justice system.



#### **BUILD**

Productive partnerships aimed at improving the experiences of those affected by crime.



#### **SUSTAIN**

Our impact by focusing all we do, in every area of the organisation, on making a lasting difference for people affected by crime.

Our relationships with our partners and colleagues in the justice and third sectors remain central to us delivering on our aims, as do our relationships with victims, witnesses and families across Scotland who have been affected by crime.

By listening to their experiences and views, we will be able to positively influence policy and legislation and better shape support services based on their needs.



# Achievements/ Recognitions – 2022/23

#### **People we support:**

VSS continues to support all victims of crime from across Scotland referred by Police Scotland and who request emotional or practical support. This is part of the Victims and Witnesses (Scotland) Act 2014. A key component of the support we offer is the provision of pre-court and in-court support to all vulnerable witnesses who are referred to VSS for summary and solemn criminal cases across Scotland by the Scottish Courts and Tribunal Service (SCTS), Crown Office and Procurator Fiscal Service (COPFS), Justice of the Peace Courts, and Police Scotland.

#### **EMERGENCY ASSISTANCE FUND**

- The Emergency Assistance Fund (EAF) is open to people affected by crime across Scotland who are in urgent need of financial help as a result of what they have experienced. People can access a wide range of goods and services where they have no other access to funds.
- Over 1,400 people were financially supported by EAF, with £385,500 awarded to people affected by crime.



#### **POLICY AND LEGISLATION WORK**

- In January 2023, VSS Chief Executive provided evidence to the Criminal Justice Committee on
  the Bail and Release from Custody (Scotland) Bill. Families supported by our SFBC service shared
  powerful and real lived experiences of the impact of bail to the Committee. 'VSS collaborated with
  partners to lobby for essential amendments at Stages 2 and 3 of the Bill.
- VSS responded to the consultation to review the Victim Notification Scheme, a scheme designed
  to provide information to victims and their families where the offender is sentenced to 18 months
  or longer in prison. In reflecting the views of families affected, we welcome positive changes and
  improvements to the scheme.



#### **PARTNERSHIP WORKING - BAIRNS HOOSE**

VSS is a partner of the Bairns Hoose project, which aims to provide a safe space for young people
who have been the victims of violent and sexual crimes. The pilot will allow victims and witnesses
to give pre-recorded evidence, without needing to go to a police station or court, with all support
services under one roof.
